

# Arcadia International Soccer League Rules and Regulations

All teams and their managers / coaches must adhere to the following rules and regulations. No exceptions! Please read this document carefully. A copy of this form must be signed by all players and managers / coaches in order to participate in the league.

Thank you for your cooperation.

## Registration:

There will be new ID cards issued at the beginning of each season. Old ID cards will not be honored. Each team will be given a maximum of **25** ID cards to start the season.

In case of a player drop-out, managers/coaches may turn his ID to the league director for a new replacement ID card. A replaced ID card can only be re-activated one additional time, after which the player is ineligible to play again for that team for the remainder of the season.

All ID cards cost \$8 per player. Temporary ID cards are also available for the same price on a single game basis.

Players may transfer to a different team but a maximum of one transfer is allowed.

All ID card photos must be current passport-sized photographs.

A roster of **25** players should be given to the league director **two weeks prior to the start of the playoffs**, after which no other players can be added.

## Referees:

Referee fees are \$60 per team to be paid to the league director prior to the start of each match.

**Absolute no referee abuse will be tolerated;** players or coaches doing so are subject to fine and/or suspension.

A captain's arm band is required for the team captain, making him the only eligible person to talk to the referee.

In case of a forfeit, the forfeiting team, with no exceptions, will pay the referee fees.

## Equipment:

Teams shall have a complete set of uniforms, including jerseys, shorts, and socks. Failure to do so will result in cancellation of the match. It is preferable that teams try to provide 2 sets of uniforms in case of color conflict.

Shin guards are mandatory for all players without exception.

## Game Rules:

Teams must have a minimum of **7** players to start, otherwise the team must forfeit the match.

Game start times: **First game: 6:30 P.M.**

**Second Game: 8:15 P.M.**

A 15 minute grace period will be given at the beginning of the first game.

Each team is responsible for providing one game ball for the match. All FIFA rules will be enforced.

## Disciplinary Actions:

Caution cards:           **1 yellow = 5 minutes off the field, no substitution**  
                                  **4 yellows = 1 red, no suspension, \$25 fine**  
                                  **1 red = \$35 fine + 1 game suspension**  
                                  **3 reds = Review of suspension + fine to be determined**

**Spitting** is not tolerated and a mandatory **\$50** fine plus a suspension in review is enforced.

Players, managers, or coaches instigating **fight**s will be subject to a **\$100** fine and a suspension.

Coaches entering the field of play are subject to a **\$50** fine and a caution card.

Managers or coaches must attend all league meetings or pay a **\$50** fine.

A discipline committee, composed of one appointed representative from each team, will meet to handle serious disciplinary matters that come before the league. The disciplinary committee will be convened at the discretion of the league director.

## Field Regulations:

**Alcoholic beverages are prohibited anywhere near the facility with no exceptions.** Please clean up your mess, especially around the team bench. We do not provide maid service.

Urination along the field is prohibited. Please use the restroom facility. Players urinating on the field are subject to a **\$25** fine and a game suspension.
